1. ACKNOWLEDGMENT OF ENVIRONMENTAL & SERVICE RISKS

I understand and acknowledge that services provided by Splashing Paws, LLC may involve environments and situations that carry inherent risks, including but not limited to:

- Slips, trips, or falls
- Uneven or unstable terrain (including outdoor desert environments, if applicable)
- Interaction with animals in varying emotional or medical states
- Exposure to weather conditions, heat, or natural elements
- Emotional distress related to hospice or end-of-life situations

I voluntarily assume all such risks associated with participation in services.

2. INCIDENT RESPONSE LIMITATIONS

I understand that Splashing Paws, LLC staff are trained in basic safety awareness and supportive care protocols, but are not emergency medical responders.

In the event of an incident involving:

- Injury to a person
- Injury or sudden deterioration of a pet
- Environmental or situational hazard

I acknowledge that:

- Staff may provide reasonable, non-medical assistance
- Emergency services (911 or veterinary emergency care) may be contacted if deemed necessary
- Staff do not replace professional medical, veterinary, or emergency responders

3. EMERGENCY DECISION AUTHORITY

I authorize Splashing Paws, LLC staff to take reasonable actions in good faith during an emergency situation, including:

- Contacting emergency medical or veterinary services
- Moving myself or my pet away from immediate danger when possible
- Following established safety protocols to reduce harm

I understand that such actions are taken in good faith and do not constitute medical or veterinary treatment.

4. LIMITATION OF LIABILITY (INCIDENTS & EMERGENCIES)

To the fullest extent permitted by Arizona law, I agree that Splashing Paws, LLC, its owners, employees, contractors, and affiliates shall not be held liable for:

- Injury, illness, or death occurring during participation in services
- Accidents occurring on or off-site during scheduled events or care
- Delays in emergency response due to environmental, communication, or logistical factors
- Outcomes related to decisions made by clients or third-party emergency providers
- Emotional distress resulting from emergency or incident situations

5. CLIENT RESPONSIBILITY IN EMERGENCY SITUATIONS

I understand and agree that:

- I am responsible for following all safety instructions provided by staff
- I will inform staff immediately of any medical or environmental concerns
- I will seek emergency medical or veterinary assistance when appropriate
- I assume responsibility for decisions made during emergency situations unless otherwise specified in advance care directives

6. GOOD FAITH ASSISTANCE CLAUSE

I acknowledge that any assistance provided by Splashing Paws, LLC during an incident or emergency is offered in good faith, for supportive and safety purposes only, and does not establish a medical or veterinary provider relationship.

7. ACKNOWLEDGMENT OF UNDERSTANDING

By signing this agreement, I confirm that:

- I understand the risks associated with participation in services
- I understand the limitations of staff during emergency situations
- I voluntarily assume responsibility for those risks
- I agree to release Splashing Paws, LLC from liability as outlined above
